



REGIONAL – OSHA 10 Hour Outreach for Construction Training

COURSE DESCRIPTION

This course is designed for Upper Management, Estimators, Project Managers, Superintendents, Foremen, and Construction Workers. OSHA recommends Outreach Training Program courses as an orientation to occupational safety and health for workers covered by OSHA 29 CFR 1926. Workers must receive additional training, when required by OSHA standards, on the specific hazards of the job. Upon successful completion of the course, participants will receive an OSHA construction safety and health 10- hour course completion card from the Department of Labor.

- › General understanding of the OSHA Act and the function of OSHA
- › Inform the student on the procedures and priorities of an OSHA Compliance inspection
- › Describe the rights and responsibilities of employers and employees under the OSHA Act
- › Provide students with the skill and knowledge to identify and control hazards in the workplace
- › Provide students with the tools and knowledge to control and eliminate hazards in the workplace
- › Promote a proactive safety attitude within the students

- › **Final Exam:** The final exam must be passed with a 70% to pass the course.
